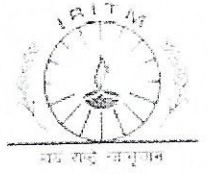

a Training Programme for non-Vigilance officers (June 27 to 30, 2017)**

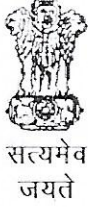

The programme will cover inputs from Railway Board, Central Vigilance Commission, CBI and Railway Vigilance officers of various departments on how to enhance transparency and efficacy in sensitive functions in Railways. This training will be particularly beneficial for officers dealing with Tenders, Contracts and all types related to various technical as well as traffic, commercial and finance departments and for disciplinary proceedings ensuing from vigilance cases. An interactive and case-study based pedagogy will be followed and nominated participants are encouraged to come prepared with their experiences and examples for sharing and discussing in the forum.

You are, therefore, requested to nominate minimum 2 officers from your railway from various departments upto & including Selection Grade to attend this training programme.

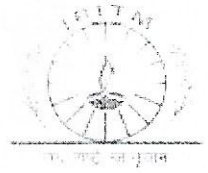
